Macquarie Ice Skating Club Guidelines

The principal activities of the club are:

- Promotion of Interest and the Participation in the sport of Figure Skating
- Supporting MISC members who are active within the sport of Figure Skating
- Training and Development of MISC members and their coaches
- Organisation of Club hosted Figure Skating competitions and NSW Test sessions
- Hosting social opportunities for MISC members, their families and friends

The club operates as an Incorporated Association under the Associations Act (NSW) 2009 and as such is not permitted to trade or secure monetary gain for its members.

The Macquarie Ice Skating Club Council is responsible for the administration and management of the club. This is achieved by conducting monthly, formalised meetings and informal discussions outside of the monthly meetings.

All Office Bearer positions are decided by nomination at the Club's Annual General Meeting. Committee positions are also voted on at the AGM. If a position is vacant throughout the year and interest is shown, this position may be filled by vote at a monthly meeting or if necessary at a "special meeting" called by the Executive.

No members of the Council receive financial reward for acting in their capacity. Council Members are entitled for reimbursement of the NSW ISA membership fee as this membership is mandatory for all council members if the Club seeks to be represented at NSW ISA Council meetings.

All Club members were insured during 2018 for personal injury and the Club for Public Liability and Professional Indemnity under the National Insurance Scheme instituted by Ice Skating Australia.

The Club Constitution empowers the Council to prescribe By-Laws that are reviewed and ratified each year.

The 2018 Council encourage parents, guardians, and skaters over the age of 18 to become involved in the MISC Committee. It is the strength of the volunteers and members that creates the successes the Club enjoys.

2018 was very successful for the club. This year we saw the return of MIRA, which was a resounding success with many members competing. The club championships were also very well attended. At the end of the year, Macquarie Rink hosted the Australian Figure Skating Championships. Many of our members competed with skill and grace against the best skaters in the country. In addition, during the course of the year, some of our members represented our club with pride at various international and interstate competitions.

I would like to extend to all our competitors my warmest congratulations. All showed exceptional dedication and commitment to the sport. Treasurer's Report

The Club is in a strong financial position with total assets of \$128,907.12 at 31st Dec 2018. These assets comprise \$41,208.95 in the MISC Operating Account, \$15,789.94 in At Call Savings and \$71,908.23 in Term Deposits.

For the year of 2018, the Club showed a gross profit of \$24,598.28, with an operating profit of \$7,554.73.

Our major sources of income this year were competition entries (\$15,836.61), Memberships (\$3,265.70), and Spectator Entry (\$1,350).

The major items of Club expenditure were athlete sponsorship (\$4,980), competition trophies and prizes (\$2,080), miscellaneous expenses including replacement prizewinner's podium (\$2,152), competition expenses (\$1,636.23) and NSWISA fees and charges (\$980).

Registrar's Report

In 2018, the MISC committee continued with the membership fees at \$50 for single memberships and \$70 for family memberships.

The Club changed from a rolling membership renewal to a fixed annual renewal date of 1 January each year, for all members. As a consequence of this change, and to ensure that all members gained one full year's membership for their subscription, those members who were still financial as of 1 January 2018 had their memberships automatically extended until 31 December 2018. All members will be required to renew for the 2019 calendar year on or after 1 January 2019.

We are pleased to report that we did have a number of new members join the club in 2018. We hope our new members continue to enjoy their skating and forge lasting friendships within the Club, as well as participating in the various Club activities and competitions.

Test Report

Test sessions were conducted at Macquarie Ice Rink in 2018 on 9 occasions with a total of 97 tests. Ice time was from 7am - 8am on Wednesday mornings during the private sessions. Start times occasionally varied for smaller testing sessions.

During the 2018 season, it was decided by NSWISA that test sessions with fewer than 7 skaters will not run, and candidates will be moved to other test sessions. It has also been decided by NSWISA that at this stage, no tests will be held at MIR in the 2019 season.
